# **Behavioral Threat Assessment Department**

# The Behavioral Threat Assessment (BTA) Department is Making a Difference!

- Provides continuous support to school leaders, School Resource Officers (SROs) and school-based teams
- Ensures the timely completion of BTAs and Student Support Management Plans (SSMP)
- Collaborates with Broward County Schools Police and Charter schools to support and ensure compliance with threat management policies

Provided professional development to over 4,000 staff members in the required Florida Model Trainings in 2024 YTD



# **Behavioral Threat Assessment Department**

# **BTA Leads the Way**

- **Receives and monitors threat reports and tips** through our **24/7/365** District Security Operations Center (DSOC)
- Supports the implementation of SSMPs for students exhibiting a high level of concern
- Conducts **quarterly audits** of the threat assessment process and the implementation of SSMPs to ensure fidelity

During the 2023/24 school year, over 3,875 Behavioral Threat Assessments (BTAs) were completed



# **Organization and Structure**

# **Reorganized for Greater Accountability**

- Added an Assistant Director of SESIR (School Environmental Safety Incident Reporting)
- Created a Mental Health Department
- Created an Emergency Management Department
  - Adding Emergency Management Coordinators to support overall readiness
- Added School Security Compliance Coordinators to support compliance with school safety legislation
- Rebranded Special Investigative Unit (SIU) to Broward County Schools Police

- Students, parents, and community leaders





## SaferWatch Panic Alerts

# Access, Integration and Innovation

- All District-owned computers now automatically open the SaferWatch app
- All District-owned cellphones have the SaferWatch app
- Incorporating a "Lockdown Drill" function for Principals and APs
- Implemented "Staff Assist" Function for nonemergencies for all employees





# **Random Weapon Screening Program**

### **Random Screenings are Working**

- Random Weapon Screening Program in place since 2021/2022
- Schools and classrooms are randomly selected, and <u>all</u> students are screened for weapons
- Frequency increased from three to five days per week
- Last year, 10.5% more students were screened resulting in a nearly 38% increase in the interception of prohibited items
- 21% decrease in weapons discovered

Random Screening	22/23	23/24	YOY Variance
Locations Screened	279	291	4.3%
Students Screened	14,756	16,303	10.5%
Prohibited Items Removed	1,029	1,415	37.5%
Weapons	111	88	-20.7%

## **Perimeter Fencing**

# Investing in the Safety of School Campuses

- Realigning capital funding priorities to improve perimeter fencing conditions
- Perimeter fencing being expanded to include all visitor parking areas at all schools
- Allows security personnel to engage
  visitors before entering the campus

### **Intercom Systems**

- A new Intercom Initiative underway:
  - 220 schools assessed for intercom enhancements
  - Scope of need identified: 87 high, 122 medium, 11 low
- Operational enhancements are in place:
  - New specs approved
  - Working with Facilities and Procurement on new bid
  - Reorganized project team
  - Deploying a turnkey implementation model

# **PROMISE Program Status and New Initiatives**

# **PROMISE** has been eliminated!

- Law enforcement is informed of all SESIR incidents and processes criminal violations, not the District
- The District supports students' underlying social and emotional challenges with:
  - Alternative to External Suspension (AES) Programs for Grades K-12
  - Interventions Making Positive Adjustment Change (IMPAC) Program for Grades 6-12
- At AES/IMPAC, students receive interventions, including:
  - Mental health intake
  - Referrals to outside services and providers to address underlying personal, familial, and/or community issues resulting in misbehavior
  - Infraction-specific curriculum interventions
  - Mentoring and conflict mediation at sites
  - Onsite access to mental health providers
  - Transition planning and follow-up providing students additional support and monitoring upon return to their home school



# Expulsions

# Student expulsions reported starting in 2024/25

#### Students expelled from school and school activities:

#### Prior to 2024/25

 Students were assigned to a District Expulsion Abeyance Behavior Intervention Program; however, no expulsions were reported

#### Beginning 2024/25

- Students possessing a firearm or other weapon and students making threats to commit a mass shooting or bomb threat will be reported as expelled
- During the period of their expulsion, students are **offered continuing education services** at a District behavior intervention program
- Students involved in any serious incident are assigned to a District behavior intervention program and cannot attend a traditional school campus until they meet the exit criteria of the program



## **Metal Detectors**

# **Investing in Weapon Detection Systems**

- Metal detectors will complement the Randomized Weapon Screening Program
- Metal detectors will be operational in <u>all</u> high schools this upcoming school year
  - Invested \$1.8 million for 100 units
  - Successfully piloted at two high schools this summer
- The platform:
  - Allows for maximum throughput
  - Is portable and can be used at other events
  - Is used by other Florida school districts
  - Is being communicated with parents and students
- <u>All</u> students and visitors will be screened
- Thanks to referendum funds, metal detectors will be staffed by District security

# Deaf and Hard of Hearing (DHH) Students

# Leveraging Technology to Support Students



- Four BCPS schools serving DHH
  population are receiving visual
  notification systems
- New systems use visual displays in classrooms and common areas to enhance emergency and routine communications
- SaferWatch integration
- Systems will be fully operational at all four schools at the start of the 2024/2025 school year
- BCPS will be an example to follow for systems of this scale

# **Safety Innovation**

- BCPS established a new drone program in 2024
- Developed with FAA's Law
  Enforcement Assistance Program (LEAP)
- Used to monitor large-scale events and site assessments

# **Enhancing Connectivity with Technology**

- Currently assessing first responder radio frequency strength
- BCPS is currently developing an Agreement that will allow first responders to utilize the Motorola Smart Connect® feature on their portable radios to connect to their primary radio systems while inside our schools and sites





## The Stronger Connections Grant

# **Leveraging State and Federal Funding**

\$3 Million in new grant funding secured through FLDOE

#### Three-year grant provides:

- **De-escalation training** for all staff to support students in crisis
- Occupational training to the District's safety and security workforce
- Additional intervention opportunities for students with poor attendance to connect students and families with resources







# **Mental Health**

- Mental Health Professionals are available in <u>all</u> schools
- Family counseling therapists provided services to more than 3,000 students free of charge
- Hired 40 of 60 Student
  Support Instructional Specialists to
  support student mental health needs
  and provide referrals
- Launched Help is Here campaign to connect students needing support to resources and trusted adults at school





#### Help is Here Campaign

- Features PSAs, posters and school events
- Encourages students to identify trusted adults they can turn to at school



# **Mental Health**

- Baker Act Transportation Pilot under development
- Terrace Metrics Screener administered to more than 3,600 students
- Summer Wellness Checks conducted for 700+ students with Suicide Risk Assessment Safety Plans and Student Support Management Plans
- Wellness Center Initiative expanding from two to six BCPS locations
- Family Wellness Nights launched at multiple schools

- K-9 Program to support Random Weapon Screening Program
- Here Comes the Bus app offers
  parents awareness of where their
  students are
- Keep it Closed! Campaign
- No Weapons on Campus Campaign
- Safety orientation training for new and substitute teachers
- Security Certifications
