## State of Florida Civil Asset Forfeiture Annual Report Fiscal Year 2017-2018

Pursuant to Section (s.) 932.7061, Florida Statutes (F.S.), every law enforcement agency shall submit an annual report to the Florida Department of Law Enforcement (FDLE) by December 1, indicating whether the agency has seized or forfeited property under the Florida Contraband Forfeiture Act and detailing receipts and expenditures of those seizures/forfeitures.

For fiscal year 2017-2018, a total of **411** law enforcement agencies were identified by the FDLE Professionalism Division. The following duplicate entries were identified.

#### Police Departments:

- Florida Panhandle Technical College Police Department (duplicate entry); and
- Washington District Schools Department of Public Safety (correct name).

#### State Agencies:

- Department of Corrections, Office of the Secretary (duplicate entry); and
- Department of Corrections, Office of Inspector General (correct name).

#### Sheriff's Offices:

 Miami-Dade Police Department is identified on the Sheriff's Office and Police Department agency lists (duplicate entry). This agency data is captured in the Police Department category.

Of the remaining **408** agencies identified, four agencies were established during the 2017-2018 fiscal year and four agencies were <u>not</u> required to comply with the reporting requirement due to the reasons indicated below:

- Alachua County Public Schools Police Department New agency established;
- Citrus County School Board Police Department New agency established;
- Jackson County School Board Police Department New agency established;
- Nassau District School Department of Student Safety New agency established;
- Okaloosa County Airport Police Department Agency disbanded;
- Department of Juvenile Justice Headquarters No longer has a sworn component;
- Department of Transportation No longer has a sworn component; and
- Port Miami Division of Seaport Law Enforcement The Seaport Operations Bureau is a
  division of the Miami-Dade Police Department. All civil asset forfeiture data (if any) is
  included in the Miami-Dade Police Department civil asset forfeiture report.

A total of **400** agencies were required to comply with s. 932.7061, F.S. One hundred percent complied; therefore, notification to the office of the Chief Financial Officer at the Department of Financial Services for non-compliance was not warranted.



FDLE received a total of **402** annual civil asset forfeiture reports:

- 280 Police Departments;
- 66 Sheriff's Offices;
- 18 Colleges/Universities;
- 17 State Agencies; and
- 21 State Attorneys.

The annual reports received included reports from two additional agencies not identified as law enforcement agencies. The agencies are identified below:

- CSX Transportation Railroad Police (Agency Type: Police Department) Pursuant to Chapter 354, Florida Statutes, Special Officers for Carriers; and
- Metropolitan Bureau of Investigation (Agency Type: State Attorney) A multi-agency task force, empowered to conduct narcotics, vice and organized crime investigations across jurisdictional boundaries throughout the Ninth Judicial Circuit Orange and Osceola Counties. (This is not a law enforcement employing agency; the officers who are part of this task force are certified under Chapter 943, Florida Statues, under their employing law enforcement agency.)

Information was extracted from **402** agency annual reports received. The summary below and the enclosed report reflect this data (see Attachment A).

- Total revenue of \$275,471,798.35 from direct forfeiture, interest income or received from other agencies.
- Total expenses of \$30,159,502.96 disbursed as follows:
  - Drug treatment, drug abuse education, drug prevention, crime prevention, safe neighborhood, or school resource officer programs;
  - Matching funds for federal grants;
  - Protracted or complex investigation cost defrayment;
  - Additional equipment or expertise;
  - Automated external defibrillators for law enforcement vehicles;
  - Transferred to other law enforcement agency; and
  - Other law enforcement expenditures (see Attachment B).
- The types of property seized were as follows:
  - Real property;
  - Personal property;
  - Currency;
  - Conveyance (vehicles, vessels, aircraft, etc.); and
  - Other (see Attachment C).



- The types of primary offenses were as follows:
  - Chapter 316 State Uniform Traffic Control;
  - Chapter 322 Driver Licenses;
  - Chapter 787 Kidnapping; False Imprisonment; Luring or Enticing a Child; Custody Offenses;
  - Chapter 796 Prostitution;
  - Chapter 810 Burglary and Trespass;
  - Chapter 812 Theft, Robbery, and Related Crimes;
  - Chapter 817 Fraudulent Practices;
  - Chapter 849 Gambling;
  - Chapter 874 Criminal Gang Enforcement and Prevention;
  - Chapter 893 Drug Abuse Prevention and Control;
  - Chapter 895 Offenses Concerning Racketeering and Illegal Debts;
  - Chapter 896 Offenses Related to Financial Transactions; and
  - Other (see Attachment D).

  - Returned to owner;
  - Forfeited:
