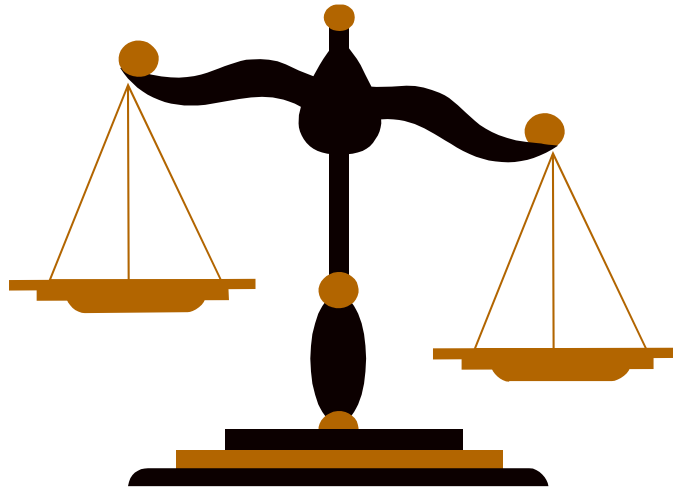

RECOMMENDATION: Chairman Ford requested a motion to approve the May 2026 Commission meeting agenda.

COMMISSION ACTION: *Commissioner Riedl moved that the Commission approve the minutes; seconded by Commissioner Nebbeling; motion carried.*

APPROVAL OF THE FEBRUARY 19, 2026, COMMISSION MEETING MINUTES

Chairman Ford asked if there were any amendments to the February 2026 Commission meeting minutes. Commission Secretary Kim Rowell stated there were no amendments.

RECOMMENDATION: Chairman Ford requested a motion to approve the February 2026 Commission meeting minutes.

COMMISSION ACTION: *Commissioner Woods moved that the Commission approve the minutes; seconded by Commissioner Barclay; motion carried.*

RESOLUTIONS

Commission Secretary read two resolutions into the commission record. The first resolution was presented to Florida Department of Law Enforcement (FDLE), through the Criminal Justice Professionalism Standards and Training Services Division and Criminal Justice Excellence Unit for their completed work and published a state-level, proof-of-concept methodology to accurately determine suicide cases among active and former sworn law enforcement and corrections officers by cross-referencing Florida death certificates with FDLE's Automated Training Management System (ATMS) certification database.

The study verified 444 officer suicide deaths statewide over the timespan of 2013 – 2023. The research was peer-reviewed and published in Policing: An International Journal.

The Commission recognized the FDLE research team for their contribution to officer wellness and evidence-informed policy, including authors Matthew H. Sharp, Zachary J. Durrett, Chadwick L. Brown, Melissa J. Bujeda, Mike Phillips, David B. Binder, Matthew J. Walsh, and Brett H. Kirkland.

The second resolution was for read into Commission record for Robert Bates. Robert Bates has been a member of the Florida Department of Law Enforcement since February 7, 2020, serving as a Research and Training Specialist; Government Analyst II, and Training and Research Manager.

Mr. Bates was a dedicated member of the Bureau of Training and made significant contributions to the development of Florida's criminal justice standards and training programs during his tenure, including developing training for basic recruit training firearms revision and multiple advanced and specialized courses. The Commission commends Mr. Bates for his contributions to the criminal justice field during his tenure with the Florida Department of Law Enforcement, Criminal Justice Professionalism Standards and Training Services, and wishes him well in future endeavors.

RECOMMENDATION: Chairman Ford requested a motion to adopt the resolutions as read into the record.

COMMISSION ACTION: *Commissioner Stahl moved that the Commission adopt staff's recommendation; seconded by Commissioner Garrison; motion carried.*

TRAINING CENTER DIRECTORS' ASSOCIATION REMARKS

TCDA Chairman Rick Davis, director of the North Florida College, Public Safety Academy provided the following report from the business meeting held on May 13, 2026.

Introduction of New Directors – Chairman Davis welcomed and introduced three new training center directors: Director Ian Sklar from the Broward County Sheriff's Office, Institute for Criminal Justice Studies; Director Mark Conner from the Orange County Sheriff's Training Center; and Director Alain Sanchez from the Miami-Dade Sheriff's Training Center.

Annual Elections – Director Wayne Boulter of the Broward College Institute for Public Safety was elected as vice-chairman; Director Damon Plonczynski of the Hillsborough County Sheriff's Office Training Academy was elected as

at-large chair; and Director Janet Hartman of the Tallahassee State College, Florida Public Safety Institute was elected as north chair.

Red Dot Systems (RDS) – Chairman Davis indicated that in collaboration with the Florida Police Chief’s Association, the Florida Sheriff’s Association, and the Florida Department of Law Enforcement, a request for subject matter experts (SMEs) currently involved in the RDS optics training system will be sent out to update the existing high liability SMEs. He further stated that they will move forward in developing a specialized course in RDS optics training.

FEMA ICS-100 and ICS-700 Training – Chairman Davis gave an update regarding the government shutdown and the impact it had on critical incident curriculum. He mentioned that staff have been working with Florida Department of Emergency Management (FDEM) to host equivalent courses within the learning management system. He stated that it is essential to ensure that Florida’s equivalent ICS-100, ICS-700 and other courses align with the federal guidelines for agencies applying for federal grants. He also stated that the current curriculum requires recruits to take the FEMA ICS-100 and ICS-700 and there will need to be an update or change to the current curriculum.

Coordinators Training Committee – The Coordinators Conference has been held every year at Polk State College. The TCDA is forming a committee that will focus annually on coordinating the training programs for the yearly conference.

2026 Chairman’s Choice Award – The 2026 Chairman’s Choice Award was presented to Sergeant Jill Dentel, from Polk State College. Director Davis stated that Sergeant Dentel was instrumental in putting together the Coordinators Conference and recognized her for her service and commitment to both the association and the coordinators’ workshop.

75 Form – Director Davis stated that there were questions regarding the 75 Form which will be included in the rules package. He noted that there may be some language issues that need to be addressed to ensure it meets all necessary requirements before it is submitted to the Commission for final approval.

AGENDA ITEM 1: CRIMINAL JUSTICE PROFESSIONALISM, STANDARDS AND TRAINING SERVICES UPDATES

Director Chad Brown of the Criminal Justice Professionalism, Standards and Training Services (CJPSTS) Division gave an update on Division and legislative initiatives.

Trust Fund Update: Director Brown provided a report regarding the Criminal Justice Standards and Training Trust Fund revenues.

Trust Fund revenues were up 7.8% or \$166,614 over the third quarter of the fiscal year 2024-2025 for court costs and traffic infractions. Trust Fund revenues for school speed zone infractions have collected \$1.8 million this fiscal year. The Trust Fund balance on March 31, 2026, was \$9.87 million. Officer Training disbursements will be around \$6.44 million for the fiscal year 2025-2026. Fiscal Year 2026-2027 allocation for officer training remains the same. The proposed distribution of \$6.44 million for officer training is based on the regional officer count of 85,027 at the rate of \$75.73 per officer.

Legislative Updates: Director Brown gave an update on the following legislative issues.

House Bill 1153 and Senate Bill 1734: Juvenile Justice – became law in March and it amends the definition of “officer” in s. 943.10(14), F. S., to include juvenile detention officers and juvenile probation officers for the Department of Juvenile Justice (DJJ). This creates an inconsistency with other officer types as the 1,800 juvenile detention and probation officers are not subject to overview and regulation by CJSTC. This inconsistency may be addressed in a future legislative session so that all officer types fall under the CJSTC.

Additional FDLE resources and staffing will be needed for the job task analysis, training development, delivery, certification, disciplines, and other areas if future legislation brings the DJJ and staff members under CJSTC oversight and enforcement.

Senate Bill 418 and House Bill 365: Law Enforcement Officer Interactions with Individuals with Autism Spectrum Disorder (ASD) – is currently awaiting the governor's signature. It creates a "blue envelope program" that helps individuals with ASD communicate with law enforcement officers and mandates topics to include in CJSTC training. People with autism may request a blue envelope or a blue card through FLHSMV or a tax collector's office beginning January of 2027.

Revision to the current four-hour CJSTC specialized course Autism Spectrum Disorder and Awareness increases the course duration to eight hours and covers all topics outlined in the bill.

The lessons in basic recruit training (BRT) on interacting with people with autism addresses some but not all topics. BRT will also require updates, which should be included in the law enforcement 2027 revision.

Law enforcement BRT is currently 770 hours. There is a need to assess the existing curricula to decide if current content can be modified to make room for the new material. Increasing the overall number of hours for BRT would require the Department of Education's (DOE) involvement as well as the Commission's approval.

FDLE Legislation: Director Brown informed the Commission that the proposed legislation by FDLE did not advance through messaging. Many of the same legislative budget requests will be reintroduced next year, which includes an increase in funding for officer training and the addition of twenty-four staff positions within the division. The staff will be responsible for beginning the job task analysis for DJJ and provide support for the School Guardianship Program, the Medical Examiners Commission, and officer discipline case work.

CJPS&TS Division Update: Director Brown welcomed and introduced Khaylah Bonner as a new case specialist and Jamie Peeters as a new training and research manager for the division.

AGENDA ITEM 2A: CRIMINAL JUSTICE STANDARDS AND TRAINING TRUST FUND OFFICER TRAINING MONIES: TRUST FUND AUDIT RECOMMENDATIONS FOR REGIONS IX, AND XV FOR FY 2024-2025

Bureau Chief Glen Hopkins presented this agenda item to the Commission and provided the trust fund revenue audit recommendations. Bureau Chief Hopkins also acknowledged the perfect audits were presented on Wednesday, May 13, 2026.

1. Section 943.25(4), F.S., requires that the Commission establish, implement, supervise, and evaluate the expenditures of the Criminal Justice Standards and Training Trust Fund for Commission-approved advanced and specialized training program courses.
2. Rule 11B-18.010, F.A.C., requires that the Commission audit any training facility or program and fiscal agent's accounting records and procedures for compliance with laws, rules, budget provisions, and contractual agreements.

AGENDA ITEM 2B: CRIMINAL JUSTICE STANDARDS AND TRAINING TRUST FUND OFFICER TRAINING MONIES: FISCAL YEAR 2026 – 2027 OPERATING BUDGET REQUESTS

Bureau Chief Glen Hopkins presented this agenda item to the Commission to request approval for allocation of officer training monies for Fiscal Year 2026 – 2027 Operating Budget Requests.

1. Section 11B-18.0052, F.A.C., requires the Criminal Justice Professionalism Division to notify the Regional Training Councils of the projected allocation of officer training monies by July 1 of each year.
2. The proposed distribution of the \$6,439,198.68 allocation is determined by the total regional officer count of 85,027 at the rate of \$75.73 (rounded) per officer. Each Commission-certified criminal justice training school submits a budget request to their Regional Training Council for approval and the Regional Chairpersons forward the respective region's budget(s) to Commission staff for review and approval.
3. Operating Budget Requests.
 - A. All budgets shall comply with the following Officer Training Monies Expenditure Formula:
 - Administrative Category - No more than 5%
 - Training Category - No less than 80%
 - Operating Capital Outlay Category - No more than 15%
 - B. Details for the Fiscal Year **2026 – 2027** Operating Budget Requests begin on **page 2**. These budgets have been reviewed and approved by Commission staff.

AGENDA ITEM 3A: OFFICER TRAINING: SPECIALIZED TRAINING PROGRAM COURSE: APPROVAL OF COURSE 022 AUTISM SPECTRUM DISORDER AWARENESS (UPDATE)

Bureau Chief Glen Hopkins presented this agenda item to the Commission to request approval of the revised Specialized Course, 022, Autism Spectrum Disorder Awareness.

1. The Commission is responsible for maintaining specialized training program courses for Commission-certified law enforcement, correctional, and correctional probation officers. Courses in the Advanced Training Program may be delivered using Criminal Justice Standards and Training Officer Training Trust Fund monies.
2. Every year, several law enforcement officers throughout Florida attend and complete the 4-hour Specialized Course, 022, Autism Spectrum Disorder Awareness. The training was developed years ago and needed revision.

With the anticipation of SB 418 passing, which requires law enforcement officers to complete an online training on the nature and manifestation of Autism Spectrum Disorder (ASD), techniques for interviewing or interrogating a person with ASD, de-escalation strategies, and more, by July 1, 2028, Commission staff decided to update the course to include the contents of the bill. This update ensures that Florida law enforcement officers receive the most current training on how to recognize and interact with people who are diagnosed with ASD. The content in the updated course will also be used to create the online training required by SB 418.

3. Commission staff worked with subject matter experts (SMEs) to update the curriculum to reflect contemporary methods and best practices for responding to and interacting with people on the autism spectrum. These updates include additional information on the nature and prevalence of ASD, common co-occurring physical and psychiatric conditions, safety risks associated with ASD, techniques for locating a person with ASD who has eloped, techniques for identifying potential abusive or coercive situations, information on voluntary identification programs for people with ASD, and more. Due to the added material, the course hours have been increased from 4 to 8. The SME workgroup also revised and developed optional role-plays to help officers practice skills in interacting with a person with ASD.

RECOMMENDATION: Commission to approve the revised 8-hour Specialized Course, 022, Autism Spectrum Disorder Awareness, in the Specialized Training Program with an effective date of May 14, 2026.

COMMISSION ACTION: *Commissioner Riedl moved that the Commission adopt staff's recommendation; seconded by Commissioner Garrison; motion carried.*

Bureau Chief Glen Hopkins presented this agenda item to the Commission to discuss Ignacio Santiago Sanchez and charges that he engaged in conduct that subverted or attempted to subvert the Basic Abilities Test Process, pursuant to alleged misconduct associated with Rule 11B-35.0011, F.A.C. Mr. Sanchez was not present.

Section 943.17(1)(g), F. S., requires that applicants entering a Commission-approved Basic Recruit Training Program pass a Basic Abilities Test (BAT) for the discipline in which training is sought. Further, Rule 11B-35.0011, F.A.C., details misconduct relating to the Basic Abilities Test and the appropriate disciplinary action for such misconduct. This issue addresses alleged misconduct on the part of Ignacio Santiago Sanchez.

1. Jose Ignacio Santiago Sanchez took and failed the Correctional Basic Abilities Test at Florida Gulf Coast University on February 17, 2026.
2. Mr. Santiago Sanchez provided the Lee County Sheriff's Office with documentation, on page 7, indicating that he had passed the Correctional Basic Abilities Test at Florida Gulf Coast University on February 17, 2026.
3. The documentation provided by Mr. Santiago Sanchez to the Lee County Sheriff's Office, indicating a passing BAT score, was an apparent forgery and was an attempt on his part to gain entry into the Correctional Officer Basic Recruit Training Program under false pretenses.
4. On March 3, 2026, the Lee County Sheriff's Office notified Commission staff that Mr. Santiago Sanchez subverted the Basic Abilities Test process.
5. Supporting documentation from Pearson VUE's, I/O Solutions can be found on page 8-11.
6. Documentation provided, on pages 8-11, indicates that the test results from Mr. Santiago Sanchez's February 17, 2026, test were altered to reflect a passing score for Mr. Santiago Sanchez on I/O Solutions Correctional Basic Abilities Test on February 17, 2026.
7. ATMS records on pages 4-5 show that Mr. Santiago Sanchez is not currently a certified officer or an applicant for certification.

RECOMMENDATION: Commission staff recommends that the Commission find that probable cause exists and that Jose Ignacio Santiago Sanchez did engage in conduct that subverted or attempted to subvert the Basic Abilities Test Process, and direct Commission staff to **(1)** Nullify all Basic Abilities Test scores for all tests taken after February 17, 2026; and **(2)** Issue Mr. Santiago Sanchez a letter of intent to deny, which would prohibit him from taking a Basic Abilities Test for a period of five-years from the date of the final order, pursuant to Rule 11B-35.0011, F.A.C.

Section 943.17(1)(g), F. S., requires that applicants entering a Commission-approved Basic Recruit Training Program pass a Basic Abilities Test (BAT) for the discipline in which training is sought. Further, Rule 11B-35.0011, F.A.C.,

details misconduct relating to the Basic Abilities Test and the appropriate disciplinary action for such misconduct. This issue addresses alleged misconduct on the part of Paris Hollis. Ms. Hollis was not present.

1. Paris Hollis took and failed the Correctional Basic Abilities Test at the Pearson VUE Test Center on March 25, 2026.
2. Ms. Hollis provided the Florida Department of Corrections with documentation, on page 7, indicating that she had passed the Correctional Basic Abilities Test at the Pearson VUE Test Center on March 25, 2026.
3. Documentation provided by Ms. Hollis to the Florida Department of Corrections, indicating a passing BAT score, was an apparent forgery and an attempt on her part to gain entry into the Correctional Officer Basic Recruit Training Program under false pretenses.
4. On March 30, 2026, the Florida Department of Corrections notified Commission staff that Ms. Hollis subverted the Basic Abilities Test process.
5. Supporting documentation from Pearson VUE's, I/O Solutions can be found on page 8-11.
6. Documentation provided, on pages 8-11, indicates that the test results from Ms. Hollis' March 25, 2026, test were altered to reflect a passing score for Ms. Hollis on I/O Solutions Correctional Basic Abilities Test on March 25, 2026.
7. ATMS records, on pages 4-5, show that Ms. Hollis is not currently a certified officer or an applicant for certification.

RECOMMENDATION: Commission staff recommends that the Commission find that probable cause exists and that Paris Hollis did engage in conduct that subverted or attempted to subvert the Basic Abilities Test Process, and direct Commission staff to **(1)** Nullify all Basic Abilities Test scores for all tests taken after March 25, 2026; and **(2)** Issue Ms. Hollis a letter of intent to deny, which would prohibit her from taking a Basic Abilities Test for a period of five-years from the date of the final order, pursuant to Rule 11B-35.0011, F.A.C.

AGENDA ITEM 6: CRIMINAL JUSTICE STANDARDS AND TRAINING COMMISSION PENALTIES IMPOSED FOR SELECT CASES REPORT

Renee Strickland demonstrated an interactive dashboard of CJSTC Officer Discipline Hearing Results. The data evaluated the results of three hearing types, Stipulation and Settlement Agreements, Informal Hearings for Moral Character Violations, and cases where the Election of Rights was received after the 21-day timeframe to respond. These hearing types were heard by the Commission from 2023 to 2025. Data could be evaluated on staff recommended outcome, type of charge, and discipline imposed.

RECOMMENDATION: This agenda item does not require Commission action.

2. The Secretary of Corrections or a designee.
3. The Commissioner of Education or a designee.
4. The Secretary of Juvenile Justice or a designee.

(b) The following persons shall be nominated by the entities referred to in this paragraph and shall become members of the board upon approval of the Criminal Justice Standards and Training Commission. Members appointed under this paragraph shall serve 2-year terms:

1. Three chiefs of municipal police departments nominated by the Florida Police Chiefs Association.
2. Three sheriffs nominated by the Florida Sheriffs Association.
3. A county jail administrator nominated by the Florida Sheriffs Association and the Florida Association of Counties.
4. A representative nominated by the State Law Enforcement Chiefs Association.

(4) The policy board shall establish administrative procedures and operational guidelines necessary to ensure that criminal justice executive training needs are identified and met through the delivery of quality instruction.

(5) Members of the policy board are entitled to reimbursement for per diem and travel expenses pursuant to s. [112.061](#) to the extent such expenses are associated with meetings or training activities, appropriate to the Department of Law Enforcement, and deemed necessary by the board.

(6) Seven members constitute a quorum of the board.

Background: The State of Florida currently utilizes the Intoxilyzer 8000 as the approved evidential breath-testing instrument. This model is no longer available for purchase and relies on outdated connectivity that is no longer optimal for agencies statewide. The Intoxilyzer 9000 has now been approved for use and will serve as the next-generation evidential instrument.

Current Status: The Alcohol Testing Program (ATP) continues working with the instrument manufacturer to finalize database requirements and upload functionality. Evidential use of the Intoxilyzer 9000 is scheduled to begin September 2026.

Training instruments and accompanying accessories have been issued to training centers offering ATP related courses. Breath Test Operator and Agency Inspector courses for the Intoxilyzer 9000 are currently underway. Permit delays are occurring for individuals who previously held any breath-testing permits. Updates to ATMS are in progress to resolve this issue, and all permits will be issued once ATMS modifications are complete.

Agencies or training centers seeking to purchase additional instruments beyond those provided by FDLE must wait until all units have been received by FDLE. We expect this to be on or around May 2027. The cost of the Intoxilyzer 9000, once available for purchase, will be \$12,742.

Mixed-instrument use (8000 and 9000) may occur for some agencies during the transition period, depending on agency readiness, training completion, and instrument availability. To ensure agencies have sufficient operational coverage a formal phase-out date for the Intoxilyzer 8000 will be established once all Intoxilyzer 9000 instruments provided by FDLE have been deployed and statewide needs and availability assessed.

 - Required to obtain a passing score of at least 80% on a written examination, and demonstrating proficiency by properly operating an approved breath test instrument in accordance with the applicable procedures for such instrument
 - Properly completing the required forms
- Submit to the Department a complete written application, Breath Test Permit Application, FDLE/ATP Form 8, upon successful completion of the 9000 breath test operator course, but no later than 90 days after completion

Agency Inspector

- Has been issued a 9000 breath test operator permit by the Department valid at the time that the application is submitted
- Successfully complete the basic Agency Inspector 9000 Course approved by CJSTC
 - Required to obtain a passing score of at least 80% on the written examination and demonstrating proficiency by proper inspection of an approved breath test instrument in accordance with the procedures for such instrument
 - Properly completing the required forms
- Submit to the Department a complete written application, Breath Test Permit Application, FDLE/ATP Form 8, upon successful completion of the 9000 agency inspector course, but no later than 90 days after completion
- Present employment by an agency of the Department

 - B. Regional Training Councils shall submit to Commission staff for approval, a separate operating budget for accrued interest.
 - C. Expenditure of accrued interest is restricted to training costs and purchase of operating capital outlay items.
 - D. The interest shall be expended on or before June 30 of the subsequent year in which it is earned.

Note: There are no interest budgets for October 2026.

4. **Property Disposals.** Commission staff has approved the removal of equipment items from the trust fund inventory of Region XVI (Florida Department of Corrections). Rule 11B-18.0053(4)(e), F.A.C., requires training schools to obtain approval from Commission staff prior to the disposal or transfer of property purchased with trust fund monies.

General Information Agenda Item: Curriculum Updates Pursuant to Section 943.17, F.S.

ISSUE

This agenda item is presented to the Commission in compliance with the statutory requirement for staff to advise the Commission of any revision to approved basic recruit, advanced, and specialized curricula.

EXECUTIVE SUMMARY

1. Pursuant to s. 943.17, F.S., the Commission is responsible for the development and maintenance of basic recruit, advanced, and specialized training programs for Florida law enforcement, correctional, and correctional probation officers. Section 943.17(3), F.S., provides that the Commission is responsible for the accuracy of curriculum content through the identification and revision of typographical or grammatical errors, incorrect statutory citations, or information which can be identified as inaccurate by superior references. The statute states that the Commission shall be advised of any revision, and a copy of revised curricula shall be provided to all criminal justice training schools.
2. Curriculum alerts were created in an ongoing effort to ensure that Florida officers receive accurate and up-to-date information in curricula approved by the Criminal Justice Standards and Training Commission. Curriculum alerts document revisions to approved curricula that are considered critical in nature. Revisions come from several sources including subject matter experts, instructors, officers, agencies, and superior references, such as the legislature and a court of jurisdiction. Curriculum alerts are distributed to training schools and posted on the FDLE website and the Automated Training Management System.
3. To further formalize and document revisions to the Commission's approved curricula under s. 943.17(3), F.S., an issue is included in each quarterly meeting packet to identify the Commission courses that have been revised within the previous quarter.
4. The curriculum changes that are reflective of "legislative action" only will be included in this agenda item. Impacted course curricula will be distributed to the training schools and certified instructors with other Commission-approved curriculum updates.

Sex trafficking of minors, or commercial sexual exploitation of children, occurs when a trafficker exploits a child younger than 18 to perform commercial sexual acts in exchange for or with the promise of money, goods, or services. Children ages 12–17 are at highest risk for a trafficker to force them into the sex trade.

In Florida, sex trafficking of minors is the most underreported, under-identified, and severe form of trafficking. It can involve ~~child pornography~~ child sexual abuse material, prostitution, or working at strip clubs, massage parlors, or escort services. Sex trafficking of minors can occur at any of the businesses listed above or anywhere that will accommodate a child and an adult. Popular online classifieds and forums, and some social networking sites, advertise trafficked children for sex.

Criminal Justice Standards and Training Trust Fund Revenue Report for Fiscal Year 2026 – 2027

ISSUE

This agenda item provides information to the Commission about Criminal Justice Standards and Training Trust Fund revenues, officer training disbursements and the trust fund cash balance for Fiscal Year 2026 – 2027.

EXECUTIVE SUMMARY

1. For the Fiscal Year 2026 – 2027, the Legislature allotted the Criminal Justice Professionalism Division **\$19.41 million** between general revenue and the Criminal Justice Standards and Training Trust Fund. The trust fund is only providing salary dollars for staff. All other expenditures are from general revenue.
2. The operating budget for officer training in Fiscal Year 2026 – 2027 totals **\$6,439,094** which provides **\$75.73** for each of the state's estimated 85,027 officers. Disbursements for the first quarter of the fiscal year will be **\$1,609,773.60**.
3. The beginning cash balance in the trust fund on June 30, 2026, was **\$11,949,698**.
