### **Welcome**

- Meeting begins at 1:05 PM; quorum is established.
- President Tucker welcomes the Foundation's two new members: Chief Jeff Devlin of Hollywood Police Department and Lieutenant Colonel Scott Champagne of Broward County Sheriff's Office.
- President Tucker requests motions to approve May's and June's meeting's minutes.
  - Mr. Hudson moves to approve the May meeting minutes. Treasurer Jones seconds the motion. The Foundation votes in favor and the May minutes are approved.
  - Ms. Thompson moves to approve the June meeting minutes. Mr. Hudson seconds the motion and the Foundation votes in favor. The June minutes are approved.

### **FMCD Finances**

#### Treasurer Update

- Treasurer Jones gives an update on the account balance, stating that the foundation has received \$10,000 since the last meeting, and going over the pending \$8,000 payment for the museum contract.
- President Tucker has filed applications with Orlando Police Department, West Palm Beach Police Department, and Publix Supermarkets, and will be following up with them.
- President Tucker suggests a motion to approve the suggested \$1,600 award purchase. Mr. Hudson moves to approve the purchase and Chief Devlin seconds. The Foundation votes in favor and the purchase is approved.
- GSOM Peoples explains that the cost to renew the Wix website for 3 years has gone up to over \$1,100. She is attempting to seek a discounted rate. Ms. Thomson moves to

approve the Wix purchase, and Lt. Colonel Champagne seconds the motion. The Foundation votes in favor and the motion is approved.

### FMCD Status

- The Mission BBQ contract needs to be signed by Treasurer Jones before moving forward. Contact information for Mission BBQ was given to FASRO for the rehearsal reception.
- The reception will now be held in the back of the banquet hall instead of in the 2nd floor meeting room, which brought down contract price by \$600.
- FASRO will be working on the Mission BBQ contract next week. The executive Director of FASRO will likely be attending FMCD.
- President Tucker suggests having a personal thank you to FASRO in the Commissioner's speaking notes.

### Secretary Atchico's Orange Park Pool Tournament Update

- 7 teams raised \$1,100 for FMCD at the pool tournament
- In addition, Secretary Atchico's charity board VP contributed \$1,000.

### Other Business

#### Texas Roadhouse Charity Days

- GSOM Peoples explains that Texas Roadhouse devotes days to charity where the day's profits go to a chosen charity. She suggests that the Foundation look into this.
- President Tucker suggests that Foundation members go to Texas Roadhouse locations in their area and attempt to arrange a charity day on the same day at multiple locations. The Foundation should look into contacting their corporate managers regarding this.
- Secretary Atchico adds that Chili's and Chick-Fil-A run similar charity days. She has been in communication with Jumbo Shrimp to work on meeting with them.
- Diena Thompson is also working on getting information about an event at a local fairground.

- GSOM Peoples additionally shares that FDLE's social media guidelines are ready for review and approval, and that she will send them to Foundation members for review before approval.
