## All 5th Grade Students and Teachers 2025 Florida Missing Children's Day Essay Contest Due by Wednesday, March 19<sup>th</sup>, 2025



The Florida Department of Law Enforcement (FDLE), the Florida Department of Education, and the Florida Missing Children's Day Foundation present the 2025 Florida Missing Children's Day Essay Contest to all 5th graders in Florida.

**PRIZE:** A winner will be selected from each FDLE region in the state. The 7 regional winners will receive \$100 dollars from the Florida Missing Children's Day Foundation. The state winner will be awarded an additional \$100 dollars, a prize package, and an invitation to Florida Missing Children's Day in Tallahassee on Monday, September 8, 2025.

**PURPOSE:** To promote safety awareness among Florida's children and encourage them to proactively think of ways to keep themselves safe from abduction.

To stay safe from abduction and predators, children should arm themselves with a good plan. There will be moments when children find themselves away from the safety of their parents. As they grow older, children encounter different situations. Whether at play, on the Internet, on social networking websites, walking to and from school, at the school bus stop or other places, all children should have a safety plan. They should ask themselves, "How can I stay safe from abduction, especially when my parents are not with me?" Parents should talk to their children and provide clear direction in this regard.

Fifth grade students across Florida are asked to write an essay about ways to stay safe from abduction. They will need to conduct research and construct their thoughts into a one page essay. The theme "This Is How I Stay Safe All Day" was chosen for the 2025 Essay Contest. The body of the essay must focus on things children can do to keep themselves safe from abduction.

We encourage all schools/programs to hold an essay contest among their 5th grade students. Each school/program must choose only one "School Winner" (except for home-schooled students, who may send their entries directly). ## THEME:

This is how I stay safe all day.



All essays are due by **Wednesday, March 19, 2025.**

Essays without school information and parental release and consent will not be considered.

7 regional winners will each receive \$100.  
Winners will be announced before the school year ends.

## PURPOSE:

To promote safety awareness among Florida's children and encourage them to proactively think of ways to keep themselves safe from abduction and online exploitation.

## CONTEST GUIDELINES:

The contest is open to all Florida 5<sup>th</sup> grade students, including public, charter, and private schools, as well as after-school programs and home-schooled students.

Each school or program can submit **only one "School Winner"**. Students that are home-schooled or whose school does not hold an essay contest may submit entries directly to the Florida Department of Law Enforcement.

The school/program information **and** the parent/guardian release and consent **must** be submitted with the essay by **March 19, 2025.**

Essays should be no longer than 1 typed page or 2 handwritten pages. If typed, essay must be in size 12 to 14 Times New Roman font. If handwritten, writing must be legible.

Essays must focus on things children can do to help keep them safe from abduction or online exploitation while at home, school, the library, a friend's house, or anywhere they might be away from their parents.

Essays may be based upon, but are not limited to: personal experiences of the child, friends, or relatives; discussions with their parents and teachers about abduction safety tips and what/where they can go to get away from uncomfortable situations; steps to avoid online exploitation in which a child may be asked to provide pictures or travel to meet another person; or interviews with people who can assist them should they encounter situations beyond their control.

Essays must be grammatically correct and free of spelling errors. Essays should demonstrate clear thought processes and be based on realistic scenarios.

## 2025 FMCD Statewide 5th Grade Essay Contest Theme: This is how I stay safe all day.

### PRIZES:

**School Winner** – Each participating school or program must select 1 winner (except for home-schooled students who may send their entries directly to the Essay Contest Coordinator). The winning essay must be submitted to the contest coordinator by Wednesday, March 19, 2025. The school contact person can submit the school winner's essay via email to [fmcd@fdle.state.fl.us](mailto:fmcd@fdle.state.fl.us). Please make sure to include the school information and parental release/consent and the school's winning essay.

*A certificate of participation will be given to all of the school winners received by the deadline.*

**Regional Winner** – All essays received by March 19, 2025, will be considered for the contest. One winner from the 7 FDLE regions will be selected as Regional Winners. The 7 FDLE regions are the Tallahassee Region, Jacksonville Region, Tampa Region, Orlando Region, Miami Region, Ft. Myers Region and Pensacola Region. See the map below of the counties by region. Essays are judged by the Department of Education and the Florida Executive Office of the Governor.

*Regional winners will receive a check for \$100 and the opportunity to be selected as the statewide winner.*

**Statewide Winner** – The statewide winner will be selected from the 7 regional winners. The statewide winner will be invited to Tallahassee to read the winning essay during the formal Florida Missing Children's Day Ceremony on September 8, 2025. The statewide winner will also receive an additional \$100 dollars and a prize package.

*At the ceremony, the statewide winner will read their essay and be presented an additional check for \$100, an award, and a prize package.*

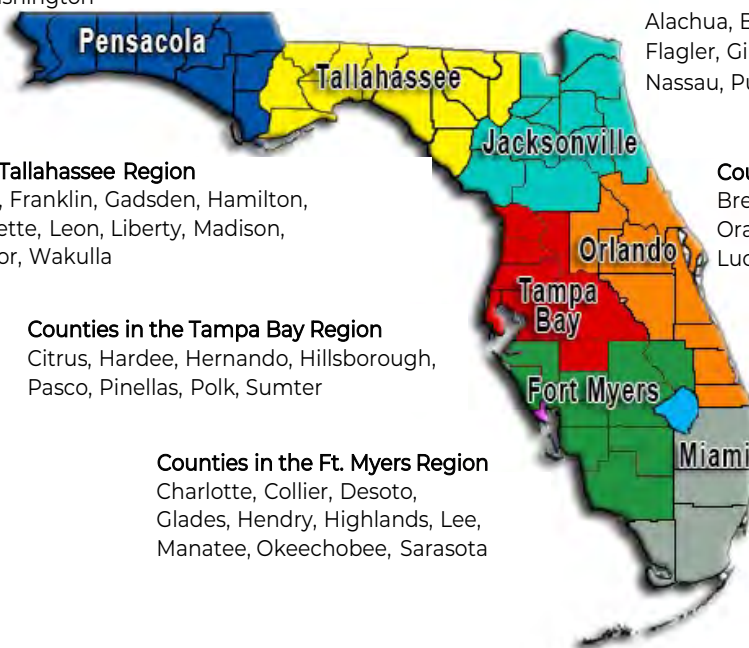

## 2025 FMCD Statewide 5th Grade Essay Contest Theme: This is how I stay safe all day.

### EDUCATORS:

You can use the theme "How I stay safe all day" as a writing prompt to generate essay topics surrounding safety. Some suggested topics are:

- What would you do if you were approached by a person that made you feel uncomfortable?
- What would you do if someone you know makes you feel uncomfortable?
- What would you do if a person you don't know asked you to go somewhere with them, or if they asked you for your personal information (for example: your full name, address, social media information, or school)?
- What are some ways you can stay safe online? Think about what you should not share online.
- What should you do if someone you don't know talks to you online or asks you to meet in person?
- What should you do if someone you know talks to you online or asks to meet you in person without your parent's approval or permission?

Provide examples of online safety and the "do's and don'ts" of online messaging to students. You can suggest ways to stay safe at home during family time and with their siblings. Encourage them to make their own safety plan and find out what their guardians/parents want them to do in specific situations.

If a child opts to conduct interviews for an essay, help them devise a plan so that the information gathered can be helpful. Suggested people to interview: school resource officers, family members, school officials, security officers, law enforcement officers, etc.

Sample questions include:

- What is your name and what is your occupation?
- What tips can you provide to help me stay safe from abduction?
- What tips can you provide to help me stay safe online?
- How can I get in touch with you if I need help?
- If you are not available, who else can I contact for help?

*School information, parental release/consent, and the school's winning essay should be sent to [fmcd@fdle.state.fl.us](mailto:fmcd@fdle.state.fl.us) by March 19, 2025.*

How to discuss child safety and the level of detail is left to teachers and guardians/parents that are familiar with the child and their level of understanding and appropriateness of topic.

### FAMILIES:

To stay safe from abduction and predators, children should arm themselves with a good plan. There will be moments when children find themselves away from the safety of their parents. As they grow older, children encounter different situations.

Whether at play, on the Internet, playing video games with others, on social networking websites, walking to and from school, at the school bus stop or other places, all children should have a safety plan. They should ask themselves, "How can I stay safe from abduction and other unsafe situations, especially when my parents are not with me?" Parents should talk to their children and provide clear direction in this regard.

Fifth-grade Florida students are asked to write an essay about ways to stay safe from abduction and online exploitation. They will need to conduct research and construct their thoughts into an essay.

Essay materials include a few websites children can use to conduct their research. Teachers and parents are encouraged to review and discuss these sites with the children. Doing so will help to arm them with the ability to protect themselves at all times. Listed below are helpful hints to use in the discussion:

- What would you do if you were approached by someone who made you feel uncomfortable?
- If someone tried to take you somewhere or get you to go somewhere with them, what would you do?
- If you are chatting online and the person asked you to meet them somewhere, asked you for personal information, or asked for a picture of you, what would you do?
- Have they been in a situation where they were asked to provide personal information? Have they received messages or phone calls from someone they do not know? If so, how did they handle it?

*Children should ask permission from parents before conducting interviews or going on the Internet.*
